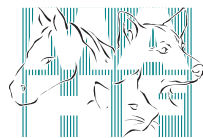

Michigan Animal Health Foundation

The Michigan Animal Health Foundation (MAHF) was created in 1969 by the Michigan Veterinary Medical Association to provide financial assistance to individuals and institutions for educational and scientific purposes that benefit animal health and welfare.

How may you support the MAHF?

Contributions to the Foundation can be made at any time. Veterinarians often make donations in memory of a deceased colleague or in the name of a client's deceased pet to express sympathy to a grieving pet owner.

Contributions are made in the name of a special client, veterinarian, friend, or relative. Consider the Foundation when planning the distribution of your estate. A contribution form is included in this brochure, should you wish to make a tax-deductible gift to the Foundation.

Who manages your dollars?

The Foundation is governed by an eleven-member board of trustees that includes a diverse group of veterinarians and four public members. The Trustees work together to determine how the grant money is allocated. The money is not pooled into a large general fund for distribution to unspecified projects.

MAHF dollars support worthy causes.

EDUCATIONAL GRANTS

The Foundation may grant scholarships and make loans to veterinary students, including those in postgraduate studies.

ANIMAL HEALTH GRANTS

The Foundation may provide financial assistance for studies designed to benefit the health and/or welfare of animals, including companion animals, livestock, and wildlife. Small, but clinically relevant projects that otherwise would have difficulty attracting funds are commonly considered.
